## 5. Fire-fighting measures

<b>Methods and materials for containment and cleaning up</b>	<p>ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air).</p> <p>Large Spills: Sweep or shovel up material and place in a clearly labeled container for waste. Following product recovery, flush area with water.</p> <p>Small Spills: Collect dust using a vacuum cleaner equipped with HEPA filter.</p> <p>Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS.</p>

## 7. Handling and storage

<b>Precautions for safe handling</b>	<b>Minimize dust generation and accumulation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Provide adequate precautions, such as electrical grounding and bonding, or inert atmospheres. Explosion proof exhaust ventilation is recommended. Wear appropriate personal protective equipment. Observe good industrial hygiene practices. Avoid prolonged exposure.</b>
<b>Conditions for safe storage, including any incompatibilities</b>	<b>Keep containers tightly closed in a dry, cool and well-ventilated place. Store away from incompatible materials (see Section 10 of the SDS). Keep away from heat, sparks and open flame.</b>
